## INTRODUCTION

Kohat Chamber of Commerce & Industry, Kohat (*the 'Chamber'*), a company Limited by Guarantee, was incorporated on December 18, 2013 under (repealed with the enactment of Companies Act, 2017) Registration # 0086173 in accordance with the relevant provisions of the Companies Ordinance, 1984. The Chamber has been registered as a Trade Body with the Federation of Pakistan Chambers of Commerce & Industry (FPCCI) as a Chamber to represent Trade, Commerce, Industry or Service or any combination thereof, in Kohat District and holds License # 173 issued on September 24, 2013 by the Ministry of Commerce, Government of Pakistan, and Islamabad. According to certification issued by Secretary General of FPCCI, Karachi the certificate issued on December 10, 2013 to the Chamber is valid for a period of five years and will remain active until renewed on a requirement basis. The major activities of the Chamber include assistance, promotion and development of trade, commerce and industry throughout Kohat Region. Being a small range or district level's Chamber, the Kohat Chamber is actively participating activities of other associate Chambers in the province and the Federation of Chambers of Commerce & Industry, just to create and feel in existence in the business community of the country and district Kohat in particular.

## ORGANISATIONAL SET UP:

The Chamber is a registered Trade Organization (TO) with the Directorate-General of Trade Organization (DGTO). It is worth adding that the DGTO is working in Pakistan as an attached department of the Ministry of Commerce, Government of Pakistan. It was established in 2007 after promulgation of Trade Organizations Ordinance, 2007, as a regulatory body to implement provisions of the aforesaid Ordinance. The affairs of the Chamber are managed by an executive committee consisting of 21-members, representing manufacturing and trading community of repute located in jurisdiction of the Region. The Chamber is obligatory to seek renewals of licenses and registration being trade organization (TO) besides following rules and regulations of the DGTO with respect to elections and results of the office bearers and executive committee members, as far as possible.

## MISSION & BROAD OBJECTIVES



KCCI- the 'Chamber' aims to promote and meet the needs of trade and industry and to create the '**best-community**' in which to live, work and do business with confidence, creativity and character building approach. Additionally, the "**Mission**" of KCCI is to provide leadership for the advancement of economic vitality and equality of life for the business community at large ensuring consistency and regularity in policies from the regulators.

## BROAD OBJECTIVES

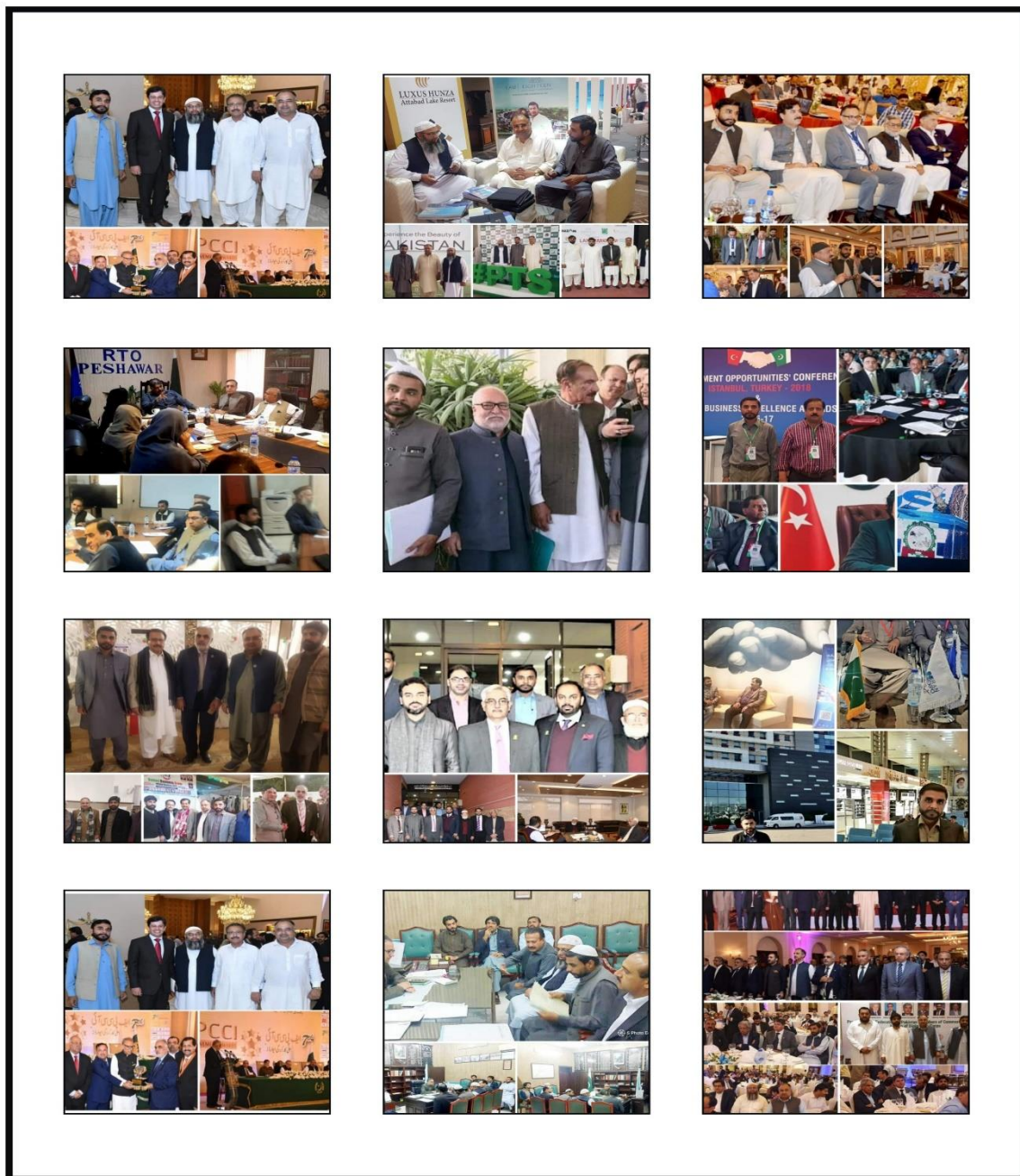
- To promote, aid, develop, stimulate and protect the economic interest of Pakistan in general and of those engaged in trade, industry and services in particular;

## QUANTIFIABLE ACHIEVEMENTS

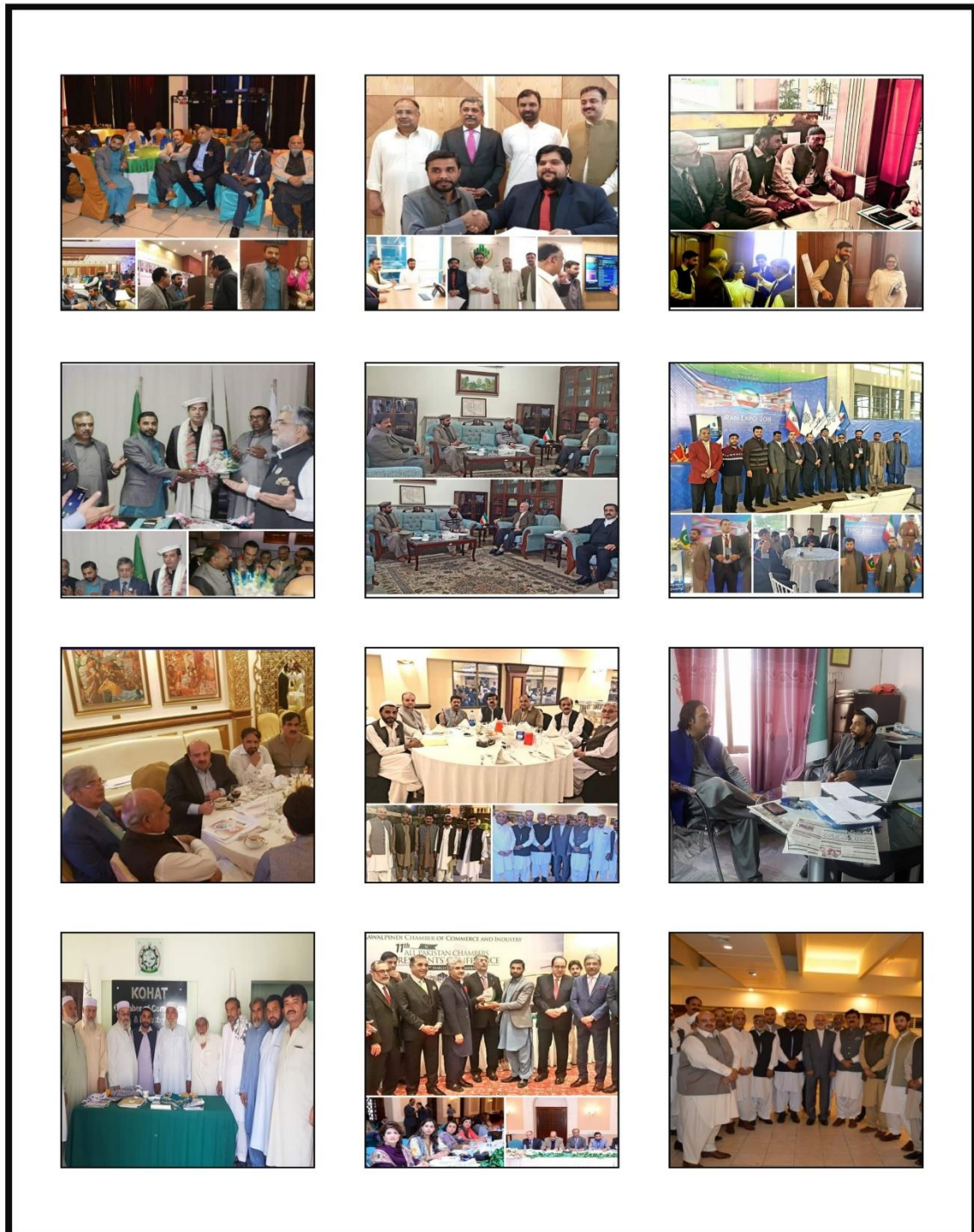

## 2. MEETING TOP-TIERS OF GOVERNMENT

## FINANCIAL STATE OF AFFAIRS

The audited financial statements for the year ended June 30, 2018 revealed that the Chamber had been able to earn a net surplus of Rs.20,826/- during FY 2017-18 (FY 2016-17 Rs.1,742) despite gross reduction in realization of the Members' Fees. Consequently, the Executive Committee had to contribute a sum of Rs.1.198 Million as Grant/Donation from within the house, in order to meet the fixed costs on account of personnel, operational and legal and professional charges.

## COMPLIANT STATUS OF THE CHAMBER

### CORPORATE & TAXATION

KCCI – the Chamber is invariably vigilant regarding its role as a corporate compliant entity as far as its corporate legal obligations under the Companies Act, 2017 coupled with requirements of DGTO, Islamabad are concerned. Likewise, the Chamber is performing an excellent role as a withholding agent as well as an ACTIVE filer under the relevant provisions of the Income Tax Ordinance, 2001.

In addition thereto, *and of course*, SCCI is in good-books of FPCCI and other associate trade bodies and CEOs/Chairman of Water and Sanitation Services Company Limited, Kohat and renowned entities operating in Kohat.

### SAFETY, HEALTH & ENVIRONMENT

The Chamber has provided safest & healthiest working environment and in this regard, has portrayed as one of the excellent Chambers in the country. Likewise, the Chamber's conferences rooms and halls meant for meetings of the dignitaries and members are exemplary and well maintained.

### HUMAN RESOURCE

KCCI had on its payroll some most essential employees because the Chamber's scanty resources at present, cannot afford employing additional HR otherwise required for the promotion of the trade and business community. Undoubtedly, HR contribution towards achievement of the promotional objectives cannot be undermined, and hence the role of the Secretary General and that of the Finance & Administration Managers are worth quote. Secretary General of the Chamber together with his team assisting in accomplishment of routine and special events has proved to be an asset for the office bearer lead by President, KCCI.

### SUNDRY ROLES:

Amongst various committees to facilitate and regulate members' matters, the Chamber has formed certain committees to manage matters relating to competitive products in conformity to the international standards and to meet the local regulatory requirements besides handling matters of quality review including but not limited to ISO certifications. KCCI has partnered with compliance and performance improvement specialists to focus Business Keys to help understanding technical regulations and standards the members need to know and to secure international certifications.

## **PROBLEMS FACED BY WOMEN ENTREPRENEUR IN KOHAT**

The President, KCCI formed a specific committee on matters concerning uplift of the Women Entrepreneurs working in Kohat Region. It may be recalled that Macrothink Institute some-time back in year 2012, conducted a detailed reporting on problems being faced by Women Entrepreneurs in Kohat aiming to find out different problems faced by them in Kohat City. Considering that particular exercise and the experience of the Chamber in general, the Chamber is of the view that Women entrepreneurs do not operate in isolation rather they work under the same macro, regulatory and institutional framework as their male counterparts in a free market mechanism in Pakistan. But it is necessary to dig deeper to understand the gender biases embedded in society which limit women's mobility, interactions, active economic participation and access to business development services.

The Chamber's experience also witnesses that in Pakistan, especially in Kohat Region, women entrepreneur faces gender base discrimination and as a result, the business conditions are not favorable for women in male dominated society, like dealing with men is difficult for women, lack of protection etc. The women entrepreneur in Kohat could be narrowed down in houses in embroidery and knitting, ready-made garments, hand-made chappals, beauty parlors, tuition centers both for Islamic and Modern Education.

The Chamber's recommend a detailed survey to be carried out for which the Chamber has approached SMEDA (Small & Medium Enterprises Development Authority), Peshawar for providing support whatever they can in exploring requisite survey and for creating awareness in women itself. Chamber believes that women entrepreneur should have enough information about their rights, business, skills, marketing knowledge and easy access to financial capital and must have strong networking and representation.
